## INTRODUCTION



**Advantage  
Vidarbha**



The growth of any industrial sector is driven by one common factor: "CHANGE". Technological advancements over the last decade have reshaped the structure of every industry and significantly developed the Information Technology sector. To thrive in a competitive market, industries must continuously adapt and innovate. Recognizing this need for evolution, the Conclave and Expo were envisioned to bridge the gap between developing and developed industries, attract fresh investments, and showcase the region's existing industrial potential, thereby encouraging youth towards entrepreneurship.

Vidarbha, comprising 11 districts, boasts rich natural resources, minerals, skilled labour, and strong educational foundations. Despite this, the region remains underdeveloped industrially. Shri Gadkari's visionary approach inspired stakeholders in Vidarbha to foresee a brighter future for the region's industrial sector, which led to the creation of the Association for Industrial Development (AID) and registered under the Societies Registration Act, 1860. Guided by Shri Gadkari, a team of 11 experienced business professionals formed an Executive Committee, taking on the responsibility of organizing this significant event with the aim of unlocking Vidarbha's full industrial potential.

The "ADVANTAGE VIDARBHA - KHASDAR AUDYOGIK MOHOTSAV 2024," an Industrial Expo and Business Conclave, was held from January 27th to 29th, 2024, at the RTMNU Campus Ground in Nagpur. Organized by the Association for Industrial Development (AID), the event focused on promoting industrial growth in the Vidarbha region. This initiative was spearheaded by Shri Nitin Gadkari, with the goal of fostering comprehensive industrial development in Vidarbha.

Nearly 35 industrial sectors were identified as part of this initiative. Each sector was led by a Convener and Co-Convener, who voluntarily planned their sector's participation in the conclave and expo.

This report encapsulates key insights, recommendations, and action points derived from the event, offering a comprehensive overview of the conclave's outcomes and its future impact on Vidarbha's industrial development.



## EVENT SUMMARY

AID planned the "Advantage Vidarbha" event under the aegis of the "Khasdar Audyogik Mahotsav." The planning began on October 27, 2023, with the launch ceremony of the AID and Advantage Vidarbha logos at Hotel Center Point, attended by participants from 35 industrial sectors, expressing support for business and economic development in the Vidarbha region.

Several sessions were organized by sector Conveners, who invited prominent national and international speakers to share insights. The Conclave aimed to accelerate industrial growth through seminars, panel discussions, and interactive sessions featuring Union and state ministers, government officials, top bureaucrats, business leaders, and investors.

On December 10, 2023, Hon. Shri Nitin Gadkari launched the official website of Advantage Vidarbha and the Bhoomipoojan ceremony of the mega event took place on January 3, 2024, at the RashtraSant Tukdoji Maharaj Nagpur University, Jamnalal Bajaj Administrative Building Campus ground, Nagpur.

The "Advantage Vidarbha - Khasdar Audyogik Mahotsav 2024," an Industrial Expo, Business, and Investment Conclave, took place from January 27th to 29th, 2024, at the RTMNU Campus, Nagpur. Organized by the Association for Industrial Development (AID) for the first time, the event focused on Vidarbha's industrial growth and economic development. A Business Conclave and an Industrial Expo provided a platform to explore growth opportunities and challenges while showcasing the region's industrial potential through the Expo.

Further, AID diligently sent invitations to speakers, sponsors, and invites, with strong support from Shri Gadkari's office. Over 200 prominent personalities, including business tycoons, investors, and industry experts accepted the invitation and actively participated in the event, fostering collaboration and

partnership-building.

Several ministries and government departments, including MSME, Defence, Aviation, Coal, Mines and Minerals, along with stakeholders from diverse sectors such as Information Technology, Gems and Jewellery, Real Estate, Fisheries, Dairy, Defence, Mining, Food Processing, and others, participated in the sessions and exhibition. The Ministry of MSME also supported start-ups and small to medium enterprises by offering subsidies to participants.

The three-day event hosted over 25 seminars and business sessions, with 8 seminars and meetings per day featuring more than 100 global business leaders and experts. The J.N. Tata Convention Centre, with a main hall seating 800 and three seminar halls seating over 200 each, welcomed over 1,400 business leaders and budding entrepreneurs daily, totalling 4,200 participants for the entire event.

15 global business leaders and investors from different countries also attended the Conclave, marking their presence throughout the event.

The Expo, spread across 5 wings and a food court, showcased over 250 manufacturing and service sector industries, with turnovers ranging from Rs. 50 lakhs to Rs. 10000 crores. Over 22000-25000 visitors attended daily, amounting to over 70000 visitors across the three days.

AID left no stone unturned in ensuring participation from every industrial sector, making the event a resounding success. Educational institutions across Vidarbha were invited, and more than 20,000 students attended, benefiting from panel discussions, lectures, and direct involvement in event planning and execution.

A key highlight was the unveiling of the coffee table book "Visionaries of Vidarbha" by Shri Nitin Gadkari and Shri Devendra Fadnavis during the concluding session. The book, featuring 40 success stories of leading entrepreneurs, professionals, and startups



from Vidarbha, serves as an inspiration for the next generation. Notable companies included Solar Group, Haldiram's, SMS Ltd., NECO, Baidyanath, VICCO, Bajaj Steel, Plasto, Infocepts, Dinshaws Confidence Petroleum, Ankur Seeds, ZIM laboratories, Vikamshi Fabrics and startups like Gramheet, agile connects and Tsecond. All featured entrepreneurs were felicitated by Shri Gadkari, celebrating their contributions to India's industrial and economic growth.

The event successfully fostered dialogue, collaboration, and partnerships among stakeholders, marking a significant step towards realizing Vidarbha's industrial potential.

## INFRASTRUCTURE DETAILS

The mega event was held at the RTMNU Campus, Jamnalal Bajaj Administrative Building Ground, Amravati – Ambazari Road, Nagpur. The meticulously planned and executed three-day event covered approximately 103,334 square feet. The venue featured four conference halls, including a main hall with a seating capacity of 800 people. Additionally, there were around 250 Expo stalls occupying an area of approximately 55,671 square feet.

An exclusively designed 'Networking & Coffee Lounge' was set up for B2B meetings and interactive seminars targeting entrepreneurs, investors, start-up aspirants, and representatives from various sectors. A Welcome Helpdesk was also established. While the Expo and sessions were free of charge, visitor registration was mandatory for security reasons. The conference halls for sessions were separated from the Expo area to minimize disruptions. Ample parking space was provided, with separate VIP parking for security purposes.

The venue included well-equipped conference halls (A, B, C, D) for sessions, seminars, discussions, and presentations, each differentiated by area and seating capacity.

**Hall A:** The main dome, covering 10,656 square feet, with a seating capacity of 800 people. Large sessions, including the inaugural and valedictory functions, were held here.

**Hall B:** Capacity of 100 people, covering approximately 1,665 square feet.

**Hall C:** Capacity of 200 people, covering approximately 4,000 square feet.

**Hall D:** Capacity of 200 people, also covering approximately 4,000 square feet.

Additionally, there were two seminar halls, each covering 25 square metres, and a round-table conference hall with a capacity of 20 people. All conference halls were equipped with LED screens and air conditioning.

A separate VIP lounge was set up for policy-level discussions between ministers and stakeholders, while a Networking & Coffee Lounge provided a relaxed atmosphere for business meetings.

The more than 250 stalls for exhibitors were organized into wings: Wing-A, Wing-B, Wing-C, Wing-D, Wing-E, and a Food Court.

Details of the stalls, along with images of a few, are shared in Annexure – A. The stalls were categorized by size and requirements.

**6. Raise Awareness Among Investors:** Make prospective investors and policymakers aware of emerging opportunities and strategic thrust areas, promoting investment and economic growth.

**7. Attracting Investments:** Encourage domestic and foreign direct investments by providing a platform for businesses to showcase investment opportunities and potential returns.

**8. Facilitating Networking and Collaboration:** Create a conducive environment for networking, collaboration, and knowledge exchange among industry players, policymakers, and investors.

**9. Showcasing Industries Strengths:** Highlight the strengths, capabilities, and achievements of the industry to attract investment and talent. Showcase innovations and success stories to build industry credibility.

## FROM THE SECRETARY'S DESK

It fills me with a feeling of great pleasure and gratitude to present this report of 'Advantage Vidarbha'- Khasdar Audyogik Mohotsav 2024. The pleasure is of connecting to people from almost all walks of life who irrespective of their business sector came under one roof with the pure intention of development of Industries of Vidarbha. The gratitude is about the confidence that our visionary and dynamic leader Hon'ble Shri. Nitin ji Gadkari, exhibited in us to organise this mega event comprising of expo, Conclave, sessions, and much more. The Journey started with the formation of the "Association for Industrial Development", that consisted of 11 members who were the established names of their business faculty. The association was duly registered under the Societies Registration Act and then the spree for planning of the mega event took pace. Initially the logo for the Association as well as the Business conclave was launched and then every sector of the industries having their units in Vidarbha became active to contribute from their end to be a part of this Mega event. Various meetings by different Sector- Conveners were held to finalise the way of their participation during the 3 day Conclave. Eminent personalities from the Industrial arena were invited and majority of them agreed to participate during the sessions. A promising response was received for participation at the Expo -stalls, ranging from the Food and Catering industry to the National Innovation Foundation – India – based units. In all

there were nearly 243 stalls erected and booked by the participants. We always received an unconditional support and timely guidance from Hon'ble Gadkari Sir's office. Invites to eminent personalities and Industrialist of India were backed by covering letters from the Office of Hon'ble Shri. Nitinji Gadkari.

The event was held during 27th, 28th and 29th of January 2024. The response was stupendous and the enthusiasm from every fraternity of Industry and education was overwhelming. Not just the established units but even the Start-ups participated during the sessions and at expo by displaying their products & services at the stalls. Many start-ups got funded by the investors and MOUs were signed during the conclave. On the very first day of the event, AID signed MOUs for start-up funding with capital ventures such as Harshraj Key Ventures, Amit Singhal from fluid ventures, specialising in B to C, "Think O" Ghanshyam Ahuja based out of Singapore, Carrat Ventures Prajakta Raut and Pankaj Bansal who are going to provide technical assistance for 2 years to 100 mid-sized companies and bring them to large companies. Also, Family offices have agreed to fund 25 lakh every year for next 3 years. On the first day i.e. 27th Jan 2024, informative sessions related to Gems and Jewellery sector; Defence Sector where Lt. Gen. Vinod Khandare along with Air Marshal Vibhas Pande, shared their valuable advises with the audience. There were also sessions related to

Aviation Sector where in some important MOUs were signed for conducting Aviation related training courses for students in order to develop employment opportunities in the region. Food Processing sector, conducted an educative discussion on Innovative value addition opportunities in pulses, grain and Cereals. An MOU was signed between the Nagpur Dal Millers Cluster Pvt. Ltd. & GFI India Ltd.

The 2nd day began with one of the highly talked about sector i.e. Coal Gasification. The session was graced by the Hon'ble Minister of State for Defence and Tourism Shri. Ajayji BhattPadma Vibhushan Dr. Vijay Kumar Saraswat from NITI Aayog, Shri. Amritlal Meena, Secretary – Central Ministry of Coal, to name a few of the luminaries present. A Vendor Development programme was also organised by the MSME Dept. where various opportunities available for the MSME units at the PSUs were discussed and briefed about e- filing of tenders and reservations maintained for growth of MSME units. Highly informative sessions were conducted on Development of Bamboo sector in Vidarbha region, Real Estate, Pharmaceutical Sector where an important MOU was signed between Keystonemab and MADC Ltd. The day summed up with the panel discussion of IT & ITES sector on topic of Nagpur as the Geographical Centre of IT where Shri. C.P. Gurnani, CEO & MD Tech Mahindra participated and shared his views regarding development of skills imparted to students to be as per the market requirement.

The concluding day saw some of the interesting and often discussed topics in the Industrial arena such as the Finance Sector where Shri. Anand Rathi – Founder and MD of Anand Rathi Financial Services gave valuable suggestions and Shri Avinash Thite shared the in-depth calculations and provisions related to calculation of GST. Logistics and Warehousing conducted a healthy panel discussion on Development of Logistics and Warehousing Industry in Vidarbha Region where established Logistics houses from across India shared their views. Panel discussion on Vidarbha as emerging Hub of mining OEMs enlightened the audience regarding the potential of Gadchiroli to become one of the world-class steel manufacturing hubs due to availability of good quality Iron in that region. The session on Tourism industry in Vidarbha ended with a positive note by the Hon'ble Minister of Tourism

Maharashtra Govt., that a new Tourism policy will be introduced soon to boost the growth of this sector in Vidarbha. The panel discussion on Techno industrial dimension on fisheries sector brought out an interesting observation that Vidarbha has both salt and gravel reservoirs and hence there is huge opportunity for fisheries here. Panellists of the Dairy sector were very optimistic on making Vidarbha a vibrant 'Dairy Hub'. For understanding the retailer expectations of expansion in Vidarbha eminent personalities from IKEA, Apparel Group, Benetton India, Samsonite, Malabar Gold and Diamonds, McDonalds India, to name a few, came together to discuss and share their observations. At the concluding ceremony a significant MOU was signed between Ramcharan Group Chennai and CIAN Agro Industries, Nagpur for Technology transfer for CO2 to Ethanol. A coffee Table book titled, 'Visionaries of Vidarbha' was released at the hand of the dignitaries present on the dais for the ceremony. The book featured the success stories of 35 leading entrepreneurs, professionals and 5 start-ups from Vidarbha.

The Expo that was going on parallelly at the same venue had around 243 stalls that featured not only the industries and retail sector units of Nagpur but also other districts of Vidarbha and Maharashtra as a whole. Dr. Anil Kakodkar



**Dr. Anil Kakodkar**, Padma Vibhushan, Nuclear Scientist (Ex Chairman, AEC & BARC) & Chancellor, Homi Bhabha National Institute, emphasized the critical need for a stronger engagement between knowledge activities and the economy. He noted that while society and the economy are inherently interconnected, there is insufficient focus on integrating knowledge-driven activities within this relationship. Dr. Kakodkar advocated for encouraging the joy of creation to elevate society from a transactional nature to a more knowledgeable one. **Varun Alagh**, Co-Founded Honasa Consumer Pvt. Ltd. (Mamaearth), while providing guidance to the young entrepreneurs/ Start up aspirants about how to establish new brands he explained that on first hand research about products to be marketed is to be done along with certification of the product brand that is to be established. He emphasised the use of E-commerce and digital media for establishment of new brands and strategies about product distribution.

He went on to explain as to how to build trust of consumers / customers in your product. He emphasised on study of consumer psychology and also consider tough times as opportunity and not adversity. He informed that many consumers have been working online and hence advertisement cost has decreased significantly since last few years. He also mentioned that "No negative proposition", does not work and one needs to propagate about what extra is been given through their product compared to the existing products.

**He said that the owners need to plan:**

- 1.Strategies as to distribution of product at best possible cost.
- 2.Pathway to achieve the expected position of the organisation after 2 years.
- 3.Capital required and allocation of that capital for the estimated growth.

**Vani Kola** (CEO - Kalari Capital), While explaining about Future of Indian Start-ups, she stated

- Significant reduction in the costing and development of start-ups ecosystem in India due to digital marketing and distribution.
- Development of public infrastructure has further lowered the establishment costs for start-up units.
- **Growth of Start-ups:** Rapid increase in the number of start-ups post the announcement of Startup India by the Central Government.
- Start-ups are emerging from every nook and corner of the country, not limited to big cities.
- Over 1,10,000 start-ups currently operating successfully in diverse sectors across India.
- Start-ups are expected to benefit smaller cities significantly in the coming decade.
- **Government Support:** Government has recognized the importance of start-ups for economic development.
- Various ministries and departments provide financial, infrastructure, and regulatory support to start-ups.

### She expressed, Key Aspects for Development of Start-up Ecosystems are as under :

1. **Education:** Importance of educating individuals about start-up development.
2. **Mentorship:** Providing mentorship to aspiring start-up founders.
3. **Access to Capital:** Ensuring access to capital investment for establishing start-ups.

### Investor-Start-up Relationship:

- Importance of alignment between the values and vision of the investor and the start-up founder.
- Emphasis on the importance of the relationship beyond just business valuation.

During her key note address she called upon the attention towards the relationship of the investor and the founder of Start-ups. She also mentioned that not just valuation of the business is important but values and vision of both parties need to align.

- He emphasised that the funds provided for startups should be used to develop a pathway to grow business.
- He also enlightened that for development of eco system, conducive for the growth of Start-up, one needs to study and leverage the existing strengths of the regions and thereby develop a stronger ecosystem for their business.
- In response to the question as to how to articulate early days of start-ups, Ms. Vani Kola elucidated that the early days of start-ups requires strong conviction at the founder's end. However, the line of conviction verses gambling is very thin and everybody needs to be much grounded to think and set certain boundaries to be followed by themselves in order to achieve the targeted business goals. Every Start-up has to think rationally about the risk taken and the price that they are willing to pay for it.

### Key Insights on **“Way forward to Atmanirbhar Bharat”** in Aerospace and Defence.

**Key note Address by:** Lt. Gen. Vinod Khandare, PVSM, AVSM, SM (Retd.), Principal Adviser, Ministry of Defence, Government of India; Air Marshal Vibhas Pande, AVSM, VSM, Air Officer Commanding-in-Chief, Maintenance Command; Rajeev Puri, Chairman and Managing Director, Yantra India Limited; C Ramchandran, Vehicle Finance, Armered India Limited.

**Nitin Gadkari**, Hon'ble MORTH, GoI welcomed all the dignitaries from the defence sector of India. In his address, he emphasized the significant opportunities available in defence exports. He highlighted that the country boasts a strong engineering workforce, whose innovative research can substantially enhance our defence exports. He also pointed out the strategic advantage of utilizing the facilities of defence and ordnance factories located in Vidarbha to develop new technologies and products. Vidarbha offers ample land for defence manufacturing, and both the state and central governments are prepared to provide the necessary policy and administrative support to advance the region's development.

Gadkari further noted that the central location of Vidarbha in India makes it a logistically advantageous area for both air and defence logistics activities. To achieve higher targets, he stressed the need for an improved work culture. Additionally, he suggested that the spare capacity of ordnance factories and DRDO should be leveraged to meet the nation's various requirements efficiently.

**Lt. Gen. Vinod Khandare**, PVSM, AVSM, SM (Retd.), Principal Adviser, Ministry of Defence, Government of India emphasized, 'In the new era, new forms of threats have emerged. To counter them, the use of new technology is necessary. In such a situation, it is essential for us to be self-reliant in the defence sector'.

This is a golden era for the defence sector, where new markets are emerging, and industries can produce goods for export also. To succeed in exports, there are several essential requirements. Firstly, we must be globally competitive in terms of quality. Additionally, niche and futuristic technology should be integrated into our production lines. Cost competitiveness is crucial, along with timely production and the ability to provide products tailored to user requirements. Most importantly, post-supply service support is essential. He emphasized that new capabilities must be developed in various domains, including cyber, space, biological, and chemical. He stressed the need to take a significant leap in the defence sector to outpace adversaries, as incremental growth alone will not suffice. A leapfrog approach to growth is necessary, he said.

**Air Marshal Vibhas Pande**, AVSM, VSM, Air Officer Commanding-in-Chief, Maintenance Command, highlighted the importance of indigenisation in the defence sector, noting that restrictions on the import of defence equipment are being imposed to foster domestic growth. He emphasized that India is now a leader in indigenisation, with over 70,000 lines of spares. Each part, no matter how small, is critical—for instance, a single split pin can ground an aircraft. This underscores the vital role that MSMEs play in the defence supply chain. While large conglomerates may dominate the industry, MSMEs will emerge as crucial secondary and tertiary agencies, integrating various products.

Marshal Vibhas Pande, Air Officer Commanding-in-Chief, Maintenance Command stressed that MSMEs have immense potential to contribute to indigenisation. Their involvement is crucial for developing robust, high-quality ships and equipment needed to strengthen the Navy. However, he pointed out that the few MSMEs currently participating are not meeting the required quality standards, indicating a need for improvement and greater engagement from MSMEs in this critical sector.

**Rajeev Puri**, Chairman and Managing Director, Yantra India Limited (YIL) — the newly formed defence PSU headquartered in Nagpur has plans to make a capital investment of Rs 600 crore for catering to the aerospace sector.

The products finally made after that, are expected to replace imports of items done by Hindustan Aviation Limited (HAL), said the company's chairman Rajeev Puri. YIL which has the ordnance factory Ambajhari as its flagship unit had been into manufacturing items like cartridge case, artillery and army shells. Post-corporatization it also began diversifying in other sectors which includes railways and aerospace.

Addressing a technical session at Advantage Vidarbha event, Puri said the company will be procuring a 10,000-ton aluminium extrusion machine for the aerospace sector catering to HAL. Puri said the company has also secured an order to make railway axles, which was bagged 40% rates lower than those offered by the private sector, he said.

Puri said YIL, which is among seven defence PSUs set up from the erstwhile ordnance factory board (OFB) in October 2021 began with a loss of Rs 800 crore. The next fiscal had a modest profit of Rs 52 core. In the current financial year, a three-digit profit is expected, he said. There is a major thrust on exports that includes independent orders apart from those bagged along with Munition India Limited another defence PSU.

Puri, however, expressed concern over growing dependence on imports of defence equipment. He said India has even surpassed Saudi Arabia and almost 10% of the world's total defence imports come to India. He said the private sector should not engage in setting up the capacity which is already existing with the government.

This is only leading to creation of excessive capacity rather than new fields in the defence sector should be explored, he said.

## Coal Gasification

**Nitin Gadkari**



Hon'ble Union Minister for Road Transport and Highways, Government of India, and Member of Parliament for Nagpur Constituency,

Union minister Nitin Gadkari during his speech, the Minister for Road Transport and Highways asked the CIL and the Coal Ministry whether "coal mines which are economically not viable and those with low-quality coal and where mining is almost stopped in Vidarbha and Western Coal Fields (WCL) areas" could be used for coal gasification projects.

He also pitched for the use of non-viable coal blocks and low-quality ones under WCL areas for coal gasification. The union minister backed public-private partnerships in coal gasification projects, coal extractions and power projects on coal pit heads. Stating that the shortage of ammonium nitrate is also affecting the mining industry, Gadkari underlined the need for the production of ammonium nitrate on a large scale. He said nano urea introduced by the Centre should be used instead of extracting the urea from coal. Gadkari reiterated the need for alternative fuel and bio-fuel for the country's future.

Not only methanol but 300 other by-products can also be produced from coal gasification which will reduce the fuel import. This is a great opportunity to develop the methanol economy in the country," he said. Gadkari said coal is available in huge quantities in Yavatmal, Chandrapur, and Nagpur districts in the Vidarbha region besides in Madhya Pradesh and Chhattisgarh where WCL is working. "These platforms can certainly help in increasing employment in this (WCL) region. Advantage Vidarbha is working towards this goal," he added.

Ajay Bhatt, Hon'ble Minister of State in the Ministry of Defence and Ministry of Tourism stated that India has moved from the 11th position to the 5th position in the world economy in the last 10 years. This is the Era of Innovation, where young people are getting numerous opportunities in science and technology to be implemented in the defence sector. Modernization and the Make in India initiative are the central government's focus. He further added that around ₹1.5 crore in financial aid is being provided for the upliftment of MSME units and the implementation of innovative ideas. The decentralization of the ordnance factory was contemplated, and an Act was passed, which was later explained to the workers and employees of different departments. Additionally, a clause named 'Sunset' was inserted in it. All DPSUs that were established have now become profit-generating units.

Managing Director, New Era Clean Tech Solution Pvt. Ltd. gave a presentation about useful gases produced during gasification of coal that are cost

effective and decarbonize the industrial sector.

#### **Suggestions**

- Acknowledged ongoing difficulties during project execution and the need for handholding.
- Highlighted the requirement for coal in both power and Non-Regulated Sector (NRS).
- Recommended long-term coal linkage for gasification to be treated as a "POWER" sector or a "special category."
- Suggested earmarking certain mines for coal gasification that are not used by subsidiaries.
- Called for rationalizing coal pricing to encourage coal gasification.

Reflecting on his seven-year journey with Zomato, Ranjan highlighted that Nagpur was the first city to launch the Zomato app. He expressed his delight at being back in Nagpur, recounting the early days when customers primarily ordered innovative foods not typically found in traditional restaurants.

### HIGHLIGHTS:

The event began with the release of a book titled "Economics of Inland Fisheries," authored by Ulhas Phadke, by the Union Minister. Nitin Gadkari spoke with great motivation to the interested entrepreneurs, asserting that if a desert like Rajasthan can export Rs. 2,000 Crore of fish products annually, then Vidarbha has the potential to export up to Rs. 50,000 Crore. He highlighted that the newly developing dry port at Sindhi could be utilized for the export of various fish products from different districts of Vidarbha. Once farmers start exporting goods and earning in dollars, they will have better purchasing power to establish their fish farming businesses.

### Key Points:

- The Fisheries sector, traditionally viewed as an agricultural activity, was given a new platform at the Industrial Expo through the visionary efforts of Hon'ble Nitin Gadkari.
- **Pulkesh Kadam** delivered a lecture on Ornamental Fisheries Development, collaborating with Pearl culturist Subodh Bais to make this industry viable and add value to it.
- **Amod Salgaonkar** presented the global market scenario, while Arpita Sharma emphasized that fish waste could be converted into manure benefiting agriculturists, florists, and vegetable growers. She also highlighted the potential for significant employment opportunities in the growing industry.



- Vikram Deshmukh showcased the development of fisheries activity in his industrial shed of 10,000 sq. ft., with 4 tanks constructed in 2,000 sq. ft., expecting a turnover of around Rs. 600,000 in one hour with the help of 2 crop fish in one season. His presentation narrated the story of industrial development in the fisheries sector in various countries, especially in South Eastern countries.

**Challenges Discussed:**

1. In India, fisheries activity is considered profitable mainly in the marine sector. In the inland sector, it is often seen as an accidental activity, with no water bodies specifically created for fisheries. Most reservoirs and tanks are used for irrigation, domestic use, and sometimes for industrial purposes.
2. Water usage for irrigation leads to a decrease in water volume, causing fish mortality and financial loss for fish farmers.
3. The fisheries sector is the only bio stock activity where feed supplements are not typically used, hampering biomass development and reducing production.
4. Fish catching is seasonal, usually only for 2-3 months, forcing fish farmers to look for other livelihoods during the off-season.

**Proposed Solutions:**

1. Promote a new dimension for industrial fisheries activities while keeping existing systems intact and undisturbed. Allocate unused industrial land for fisheries activities.
2. Subsidize feed supplements for at least the first 4-5 years.
3. Supply electricity at subsidized rates for 4-5 years.
4. Prioritize feed production units and fish waste manure production units in the state budget.
5. Strongly recommend that AID takes up these matters with authorities to make the sector prosperous and capable of contributing significantly to the Indian economy.

Tier 2 and tier 3 cities like Vidarbha are showcasing huge potential in maintaining a positive P&L for retail brands.

**Employment Opportunities** - Growth of industries and SEZ in Vidarbha region shall help in boosting employment potential.

**F&B Hospitality Discussion:** Key Panellists included Shri Anurag Katriar (NRAI), Shri Nishit Pandey

(McDonald's India) along with other industry experts explored themes including:

**Unlocking 24/7 Potential:** Panellists discussed the feasibility and benefits of 24/7 F&B operations in Vidarbha.

**Simplification of F&B Licensing Process:** Experts called for simplified F&B licensing, citing delays as a major deterrent for new entrants.

**Inspiring Entrepreneurial Journeys:** Panellists shared their personal success stories, highlighting challenges, finding solutions and experience gained in the F&B industry.

**Entertainment Industry Discussion:** Key panellists included Shri Ankur Maheshwary (Masti Zone), Shri Nitin Pandey (Timezone Entertainment). The entertainment industry panel focused on below points:

**Land Acquisition Support from Government of Maharashtra:** Entertainment Industry has a huge potential in the Vidarbha region. The Panellists requested active support from the Government of Maharashtra for land acquisition to create a world class amusement park in Vidarbha.

**Simplification of Licensing Process:** The panellists suggested to have a simplified licensing process through a single window clearance for the Entertainment Industry.

**Tourism:** Entertainment industry will directly boost the tourism sector and help in overall growth of Vidarbha region.

#### HIGHLIGHTS:

##### **Vd. Jayant Deopujari, Chairperson, Board of Governors, NCISM, New Delhi**

- Discussed the shifting global perception toward Ayurveda, particularly post-Covid-19, which underscored Ayurveda's scientific credibility and immunity-boosting potential.
- Highlighted that the pandemic led to increased adoption of Ayurvedic principles such as Dincharya, Ritucharya, and practices including Yoga and Meditation.
- Emphasized the need for stringent regulatory frameworks to ensure Ayurvedic products meet global standards.
- Mentioned government support in approving herbs under FSSAI for widespread nutritional use, stressing vigilant oversight to prevent misuse or improper formulations.
- Outlined initiatives by the AYUSH department to promote Ayurveda through scholarships, academic programs, and trade expos.

##### **Mr. Ranjeet Puranik, Managing Director, Shree Dhootpapeshwar Ltd.**

- Commended the Department of AYUSH's efforts but raised concerns over the influx of Ayurveda-based





products in the food sector, especially by FMCG companies.

- Voiced concerns over inadequate dosage in immunity-boosting products containing herbs like Ashwagandha and Tulsi, urging stricter regulations to prevent dilution of Ayurveda's credibility.
- Stressed the need for collaborative research efforts with CCRAS to make affordable Ayurvedic formulations accessible to MSMEs.
- Noted the increasing cost and scarcity of quality raw materials and herbs, impacted by regulatory restrictions on forest collections.

**Mr. Chetan Marwah, Director, Essen Herbs India Pvt. Ltd.**

- Advocated for promoting medicinal herb cultivation on private and government lands to supplement natural forest conservation.
- Proposed leveraging Vidarbha's biodiversity by engaging NGOs, SHGs, and agricultural colleges in training programs for farmers to cultivate medicinal herbs alongside traditional crops.
- Suggested involving biotech and agro-economic experts to support sustainable herb cultivation, potentially on leased forest land.
- Emphasized the economic and employment potential, including the possibility of buy-back agreements with farmers to provide the Ayurvedic industry with quality raw materials.

**Nitin Gadkari, Hon'ble Union Minister**

- Recognized Vidarbha's abundant human resources from local Ayurvedic and pharmacy colleges as a significant workforce advantage for the industry.
- Highlighted Nagpur's strategic location for industrial expansion due to its connectivity.

**Nitin Gadkari** Hon'ble Union Minister for Road, Transport & Highways, GOI stated that women of the family should lead the dairy business because of certain inherent traits in them like taking care of family members with compassion can make them tend to the domestic animal in a better way, resulting into positive impact on milk production.

**Vilas Katekhaye** Director of Krishna Dairy said, West Maharashtra is a vivid example of the fact that women are incomparable in taking care of animals with love. This is the main reason behind the highest milk production in the state, he added.

**Indranil Chitale** of Chitale Dairy said, dairy farmers in Vidarbha should try to increase the availability of fodder. Similarly, dairy products are as important as milk. Hence, if farmers do not get good price for milk, they should think of making dairy products by value addition, he added.

**Mukesh Jha** of Mother Dairy said Upkeep of animals important to increase milk yield, cowshed cleanliness is also important in milk production. If the environment where the cow or buffalo spend most of its time is sterile and clean, the average milk yield will definitely increase.
